Testifying in court is often a daunting proposition. Yet, social workers, child protection workers, and mental health professionals are regularly subpoenaed. Many professionals are unprepared for testimony even if they have previously testified. Aggressive cross-examinations can be intimidating for those called to testify. Oftentimes mental health professionals are faced with expectations from lawyers and judges contrary to their professional standards or ethics. This session will address strategies to minimize anxiety and enhance effective testimony.
